Collections Review - Museums and Heritage

Options Considered/Reasons for Decision

Newport Museums & Heritage Service currently manages its collections based on guidelines set out in the Acquisition and Disposal Policy 2009. A new Collections Development policy is currently under consideration. Both policies set out a framework for collecting decisions and seek to focus

on material that demonstrates a link to the locality of Newport. However collecting has not always been so focussed and we manage a number of objects with little connection to Newport or its history. Curatorial staff have identified a number of objects which are of no local, historic or other significance for Newport's collections which they now wish to remove from the permanent collections.

Decision

To permit curatorial staff to initiate the process to remove identified objects from the permanent collections in accordance with the Acquisitions and Disposal Policy 2009 and the proposed Collections Development Policy 2014.
