#### Land at Usk Road/Tram Road

#### **Options Considered/Reasons for Decision**

To seek approval of the Cabinet Member for Assets and Member Development (Deputy Leader) regarding the disposal of the above Council owned Land.

The Council is freehold owner of the subject land. Two applications have been received from adjoining property owners, seeking to acquire the land. The land is within an identified Flood Plain and at present likely to only be of an agriculture nature. Disposal of the two portions of land with the adjoining owners and making the remainder of the site available on a long lease on suitable terms would provide income to the Council and avoid future management and maintenance costs. This disposal will have no impact on the level of open space available in the ward but would support education in the area of agriculture.

This option will generate a capital receipt, produce revenue income and transfer maintenance and management costs from the Council.

#### Decision

Dispose of the land on terms to be agreed by the Head of Law and Regulation.

#### **Ellen Ridge Substation**

#### **Options Considered/Reasons for Decision**

To seek approval from Cabinet Member for Assets and Member Development (Deputy Leader) to declare part of the Ellen Ridge site as surplus to housing requirements and then to agree to dispose of the area required for the substation site by way of a long lease to Western Power Distribution.

The Ellen Ridge site has been appropriated for housing purposes, as a permanent Gypsy and Traveller site. In order for this development to proceed Western Power Distribution need to put in a substation on site to serve the development.

#### Decision

To declare part of the site as surplus, from housing use, and to then agree to dispose of the area required for the substation site by way of a long lease to Western Power Distribution.
