Section A – Committee Guidance and Recommendations

1 Recommendations to the Committee

The Committee is asked to

- 1.1 Consider the opinions of the Gwent Police representatives and Council Officers on the effectiveness of the current PSPO:
- 1.2 Approve the consultation strategy on the proposed changes to the PSPO (Appendix 3 and 4);
- 1.3 Agree to receive the outcomes of the consultation at its meeting in April, and at that stage consider the merits of the proposed changes.

2 Context

Background to the City Centre PSPO

- 2.1 Public Space Protection Orders were new measures brought in 2014 to allow Councils to control anti-social behaviour in a particular public location. They were designed to prevent individuals or groups committing anti-social behaviour where that behaviour was persistent and unreasonable and was having, or was likely to have, a detrimental effect on the quality of life of those in the locality.
- 2.2 An alcohol exclusion zone in the city centre had been in place for some 12 years, but the introduction of these new powers had provided an opportunity to review and consider putting in place a new PSPO to counter other forms of persistent and detrimental behaviour.

SSRS Scrutiny Committee - 15 October 2015

2.3 Scrutiny had been asked to oversee public consultation on the issue, consider what responses were received and to make recommendations to the Cabinet Member regarding measures they would want to see in a new Order.

The Committee made the following Recommendations:-

- 1) The Committee **recommended** that the Council should include the following measures in the Public Spaces Protection Order:
 - Alcohol Consumption;
 - Rough Sleeping;
 - Begging
 - Dogs not on leads
 - Canvassing of Services/Charities/Direct debits (unless covered by a street collection permit);
 - Fly Posting.
- 2) The Committee **recommended** that the boundary of the Public Spaces Protection Order be extended.
- With regard to the distribution of free printed materials, the Committee noted that there were problems being caused by this, notably littering. The Committee did not agree that a Public Spaces Protection Order was the most appropriate and least restrictive method of addressing this problem. The Committee **recommended** that the Council work with the Business Improvement District Board to try and put in place measures, such as a code of conduct for business operators, to address the problem of littering caused by the distribution of free printed material.
- 2.4 The Committee noted the concerns with regard to potential displacement of the current problems with alcohol consumption outside out the proposed City Centre boundary. The Committee **decided** to include an update on the implementation of the Public Spaces Protection Order (once approved by Council) on its forward work programme, to be reported to the Committee after 6 months. This update should also include detail of any issues of displacement of any of these problems outside of the proposed new boundary.

Council - 24 November 2015

- 2.5 At the Council meeting, The Cabinet Member stated he had considered Scrutiny's recommendations and also evidence and concerns from the police, the public, and businesses and from council officers and partner agencies, including those involved with housing needs and supporting people.
- 2.6 He was mindful of the importance of striking the right balance between protecting the public and respecting civil liberties and freedom of expression and movement. To this end he recognised the success of the Council's current housing and homelessness policies, and considered that existing anti-social powers were more appropriate than an outright ban in relation to rough sleeping and begging.
- 2.7 He recommended a version of the Order that did not carry a 'No rough sleeping 'measure and in which the "No Begging" measure was replaced by the following: "No person shall beg in a manner which is aggressive or intimidating, or which harasses members of the public." Following consideration, a series of three proposed amendments were lost.

ANTI-SOCIAL BEHAVIOUR, CRIME AND POLICING ACT 2014 SECTION 59 PUBLIC SPACES PROTECTION ORDER 2015 NEWPORT CITY CENTRE

NEWPORT CITY COUNCIL in exercise of its powers under Section 59, 64 and 72 of the Anti-Social Behaviour, Crime and Policing Act 2014 ("the Act") hereby makes this Order, being satisfied on reasonable grounds that activities in a public space, namely in Newport City Centre, have had or are likely to have a detrimental effect on the quality of life of those in the locality and that these activities involved various anti-social behaviours. Further, Newport City Council believes that the effect, or likely effect, of the said activities is, or is likely to be, persistent or continuing in nature, such as to make the activities unreasonable and justifies the restriction imposed by this Order:-

- 1. This Order shall come into operation on and shall have effect for a period of 3 years thereafter, unless extended by further Orders under the Council's statutory powers.
- 2. This Order relates to the public place boundary shown in red on the Plan annexed to this Order ("the Restricted Area").
- No person shall within the restricted area refuse to stop drinking alcohol or hand over any containers (sealed or unsealed) which are believed to contain alcohol, when required to do so by an authorised officer to prevent public nuisance or disorder.
- 4. No person shall within the restricted area, approach members of the public in a persistent manner with a view to persuading them to:
 - a. Subscribe to a service; or
 - b. Make charitable donations by direct debit, standing order or similar means.
- 5. No person shall beg within the restricted area in a manner which is aggressive or intimidating, or which harasses members of the public.
- 6. No person shall affix any notice, picture, letter, sign or other mark upon the surface of a highway or upon any tree, structure or works on or in a highway without permission of the landowner within the restricted area (fly-posting).
- 7. Any person in charge of a dog within the restricted area shall be in breach of this Order if he/she fails to keep the dog on a lead (of no more than 1.5 metres in length).
- 8. Any person who, without reasonable excuse, fails to comply with the requirements of this Order commits an offence and shall be liable, on summary conviction, to a fine not exceeding level 3 on the standard scale (currently £1000).
- 9. If any interested person desires to question the validity of this Order on the grounds that the Council had no power to make it or that any requirement of the Act has not been complied with in relation to this Order, he or she may apply to the High Court within 6 weeks from the date on which this Order is made.

SSRS Scrutiny Committee - 8 September 2016

2.6 The Committee received an Information Report on the progress achieved with the introduction of the City Centre PSPO Order. The Committee noted that there had been significant decreases in some of the restrictions included in the order but there were still further progress needed with others. The Committee requested an additional monitoring report in 12 months. The Meeting also highlighted the Committees desire for 'aggressive' begging to be given a clear definition which will provide the Police with something to act upon.

Current situation

2.7 The PSPO is being brought to the Committee due to the ineffectiveness of the current order at combating anti-social behaviour in the City Centre. The implementation issues have been highlighted by the Police and Council Officers, they both believe that changes can be made to the order to make it more effective. As such they have prepared this report outlining what the problems are and have suggested some changes. The role of the Committee is to discuss the perceived problems with the Police and the Council Officers.

The Committee can then consider the consultation strategy proposed by the Council Officers and see if there are any suggestions they would like to make before it goes out. Once agreed the response to the consultation will be brought back to the April meeting where the Committee will have a chance to consider the results and discuss the proposed changes, before making recommendations to Council.

4 Suggested Areas of Focus

- 4.1 It is suggested that the Committee focus on:
 - Seek feedback from Council Officers and representatives from the Police on the current issues being experienced with the PSPO;
 - Is there evidence of the issues with the current PSPO?
 - Is there evidence that the existing restrictions have been effective at tackling any of the antisocial behaviour it was set up to address;
 - Consider the consultation plan (**Appendix 3**) and determine whether the proposed consultation is targeting the most appropriate people / organisations and whether the mediums of consultation will provide the necessary information.

- 4.2 At this stage, the Committee is only being asked to agree that a review of the PSPO is needed, and to agree the consultation plan to seek the views of the public on proposed changes.
- 4.3 At its meeting in April, the Committee will be considering the outcomes of the consultation and will have an opportunity to comment on the proposed changes.

Review of City Centre Public Space Protection Order and Consideration of new or amended restrictions to be included in a revised Order

1 What is a Public Spaces Protection Order?

- 1.1 A PSPO is designed to prevent individuals or groups committing anti-social behaviour in a public space where the behaviour is having, or is likely to have, a detrimental effect on the quality of life of those in the locality; and the behaviour is or likely to be persistent or continuing nature; and be unreasonable. The power to make an Order rests with local authorities, in consultation with the police, Police and Crime Commissioner and other relevant bodies who may be impacted.
- 1.2 The Council can make a PSPO on any public space within its own area. The definition of public space is wide and includes any place to which the public or any section of the public has access, on payment or otherwise, as of right or by virtue of express or implied permission, for example a shopping centre. There are particular considerations for registered common land, town or village greens and open access land.
- 1.3 The maximum length of a PSPO is three years.
- 1.4 When making a PSPO, the Council must have particular regard to the rights of freedom of expression and freedom of assembly set out in the Human Rights Act 1998. Consideration of a PSPO will take place where there is material evidence of anti-social behaviour. Assessments will commonly include reports to the police, and various Council teams and partner agencies.

2 What kind of Restrictions can be in a PSPO?

- 2.1 Restrictions and requirements are set by the local authority and can be blanket restrictions or requirements, or can be targeted towards certain behaviour by certain groups at certain times. They can restrict access to public spaces (including certain types of highway) where that route is being used to commit Anti-social behaviour.
- 2.2 Orders can be enforced by a police officer, police community support officer and delegated council officers. A breach of the Order is a criminal offence and can be dealt with through the issuing of a Fixed Penalty Notice of up to £100 or a level 3 fine of up to £1000, on prosecution.

3 Creating the first Newport City Centre PSPO

- 3.1 The first city centre PSPO was enacted in November 2015, following consultation and oversight by Scrutiny and extensive public consultation. Our PSPO was one of the first "city centre" PSPOs to be enacted in the UK and was thus subject to intensive interest not just locally, but by national civil liabilities groups and the UK media. It was finally approved by Council where it was agreed to drop the proposed "no rough sleeping" and "no begging" restrictions, and instead, substituting for the latter, a restriction of "no intimidating or aggressive begging". A Rough Sleepers working group was also established to examine this complex issue and see what measures could be introduced to help these individuals come off the streets. Rough sleepers are not necessarily beggars and beggars are not necessarily rough sleepers.
- 3.2 The Order also included an alcohol restriction, replicating a provision that had been in place since 2001 as an alcohol exclusion zone.
- 3.3 The Order will expire in November 2018 and we consider it timely to review it now with a view to enacting a revised city centre PSPO, taking into account what has worked

over the past two years, what restrictions need to be kept or revised, and whether we need to introduce new restrictions to tackle other forms of anti- social behaviour that are occurring in the city centre.

4 Current restrictions

1.Street Drinking

No person shall within the restricted area refuse to stop drinking alcohol or hand over any containers (sealed or unsealed) which are believed to contain alcohol, when required to do so by an authorised officer to prevent public nuisance or disorder.

2. Touting for services / donations

No person shall within the restricted area, approach members of the public in a persistent manner with a view to persuading them to: subscribe to a service; or make charitable donations; by direct debit, standing order or similar means.

3. Aggressive Begging

No person shall beg within the restricted area in a manner which is aggressive or intimidating, or which harasses members of the public.

4. Flyposting

No person shall affix any notice, picture, letter, sign or other mark upon the surface of a highway or upon any tree, structure or works on or in a highway without permission of the landowner within the restricted area

5. Dogs to be on a lead

Any person in charge of a dog within the restricted area shall be in breach of this Order if he/she fails to keep the dog on a lead (of no more than 1.5 metres in length).

5 Enforcement of the PSPO

Police enforce the order at all the times of the day. Council Wardens enforce during the day, when they happen to be in the city centre. However, as the begging restriction is a ban on "aggressive" begging, is generally left to the Police and especially, as begging is much more prevalent in the late evening. Similarly, if the breach of the alcohol restriction is by more than the odd individual, then that too would be referred to the Police to action.

7. Observations on the alcohol restriction

- 7.1 Alcohol consumption is the main PSPO restriction breached. Some of the perpetrators are of no fixed abode and so there is little point in issuing them with FPNs. It is often the same people on a daily basis. Many of those identified as street drinkers are involved with various agencies to address their drink and drug problems. However, some groups of drinkers will congregate in area of high footfall causing an increase in anti-social behaviour. Recently, there has been a drive to curb their behaviour with the issue of PSPO fixed penalty notices tickets and community protection notices issued to exclude persons from the area.
- 7.2 The main issue at night appears one of "pre-loading" and indeed City Centre club owners have complained to the Police and the Council Licensing team about this problem. "Pre-loading", in so far as breaching the PSPO, is where people either:
 - Come into the city centre, often in taxis, and are dropped off on the Queensway
 having consumed alcohol at home and then also bring alcohol in with them which
 they then consume in the streets before going into the clubs; or
 - Buy alcohol in city centre convenience stores and then drink it outside in the street before going into the clubs. Some even pop out from a club, buy alcohol at a convenient store, consumer it outside in the street and then go back into the club.
- 7.3 As part of investigation into the Baneswell Express off-licence, on 27 February 2016, officers witnessed six people In the space of 15 minutes (01:05 to 1:20) buying alcohol from the store and consuming it on the street which is covered by the PSPO. This store's licence was submitted for review to the Council Licensing Sub-committee who reduced the latest time the store could sell alcohol from 1am to 10pm. This was the subject of an appeal and early in 2017, it was agreed that the terminal hour would be 11pm. The store is being monitored for compliance.
- 7.4 Whilst clearly more work needs to be done around compliance with the alcohol restriction, the introduction of the PSPO in the City Centre has produced positive changes. The extension of the geographical boundary from that covered by the original Alcohol Designation Area, that was in existence before the PSPO, has definitely helped, as previously, significant instances of street drinking were occurring just outside that original boundary. Displacement into other areas does not appear to be a problem, especially now that the PSPO for Pill includes a restriction on street drinking.
- 7.5 Nevertheless, there is still much evidence of continued anti-social behaviour resulting from consuming alcohol on the streets, especially at night and therefore, at this time, it is proposed that this restriction should remain, unaltered, in a revised city centre PSPO and active enforcement needs to take place.

8. Other city centre PSPOs

As stated above in paragraph 3.1, Newport was one of the very first city centre PSPOs. Since Nov 2015, there have been many more introduced in town and cities throughout the UK in response to anti-social behaviour issues in those areas. Examples of other cities' city centre PSPO restrictions, where relevant to the anti-social behaviour being encountered in Newport city centre, are to be found in Appendix 5.

9. What to include in a revised city centre PSPO?

9.1 Feedback from the Police and Council Community Safety Wardens in particular, and with reference to the anti-social behaviour data they have provided, it is suggested that there are two restrictions that could be amended and a possible new restriction added.

Possible Amendments:

1. Begging:

The Police state that begging is vastly under reported to them, but it is one of the main public complaints encountered on patrol. The favoured begging spots are cashpoints and car park vending machines etc. On the weekend, the begging focus changes to target people frequenting the city centres nightspots and beggars can be seen loitering around the cashpoints on Westgate Sq., Bridge St and Cambrian Rd. Beggars also frequent the Friars Walk shopping complex around the pay and display machines in the car park. The situation has been managed there by security guards moving on those that choose to beg in that area.

Police and wardens state that the current restriction of "aggressive begging" is very difficult to prove and unless they have a witness willing to give a statement they invariably cannot prove any breach.

It is suggested that in order the current PSPO restriction enforceable, then either that it should become a blanket "No begging", or at least to extend the restriction to explicitly prohibit begging within the vicinity (say within 5 or 10 metres) of a cash machine.

It is worthy of note that the Business Improvement District is set to introduce a diverted giving scheme in January 2018, to encourage the public not to give to beggars, but instead to donate through retailers in the city centre, where the funds will be transferred to the Wallich charity who work with and help the rough sleepers in the city centre. Kevin Ward, manager of Newport Now, has said:

"Diverted giving schemes, which operate in many towns and cities across the UK, offer the public an alternative mechanism to support people affected by homelessness by encouraging them to give responsibly to agencies working directly to tackle such issues. Effectively, the scheme aims to discourage people from giving to street beggars in the city centre and instead will offer alternative secure methods of donation to The Wallich, with all donations allocated to projects specific to the city centre."

With reference to other city centres' PSPOs – **Appendix 5**, several now include "No begging" restrictions or at the very least, banning begging from the vicinity of cash machines. This activity is very prevalent in Newport city centre, particularly at night.

2. **Touting for services/ donations.** Charity agents trying to secure direct debit sign ups appear to be no longer a problem, but the Council still receives complaints from the public about pedlars/ "sellers" of services such as "no win /no fee" law firms/ mobile phone / internet sellers and also people posing as collecting for a charity, when they are actually selling a product, such as a magazine. A possible restriction could be to prohibit all street trading (inc. offering services) /pedlars/charities that do not have permission from the Council (but excluding *Big Issue* sellers).

A possible new restriction

- 3. **Gang anti-social behaviour** appears to be a persistent problem especially in late afternoons and evenings. The Police state that 29% of the calls they receive in the city centre relate to gang/youth anti-social behaviour occurring from 3pm and peaking at about 8pm daily. Youths loitering near fast food outlets/ bus stations are the subject of many complaints from members of the public and business owners who are either confronted by gangs or feel intimidated by their presence when walking past them. The anti-social behaviour is worse at weekends, extending from the early to late evenings. High Street has been and remains the highest area for recorded anti-social behaviour in the city centre.
 - It is suggested we replicate the restriction that is part of the recently enacted Pillgwenlly PSPO, namely "No person shall congregate in a group of 3 or more persons within the Restricted Area AFTER an authorised person has requested that the group disperse", or instead, a variant that is in use elsewhere: *E.a. taken from Exeter City Centre's PSPO:*
 - "Not to behave (either individually or in a group) in a manner that has caused or is likely to cause a member of the public to suffer harassment, alarm or distress by that behaviour. (Persons who breach the above shall, when ordered to do so by an authorised person, disperse either immediately or by such time as may be specified and in such a manner as may be specified). "
- 9.2 Other reported areas of anti-social behaviour include: consumption/ possession of intoxicating psychoactive substances (restricted in the Pill PSPO) and inconsiderate parking.

10. Consultation on a revised PSPO

- 10.1 At this meeting, the Committee are being asked to consider the current issues of antisocial behaviour in the City Centre, the data contained in this report as to the current effectiveness of the PSPO; hear from Gwent Police as their views and then approve a consultation strategy for seeking views on potential revisions to the PSPO.
- 10.2 If agreed at this meeting, it is proposed that the Council undertakes public consultation as outlined in **Appendix 3.** This will include publicity through a press release, social media and leaflets promoting the existence of an on line questionnaire (**draft at Appendix 4**), which will ask the public views on: the anti-social behaviour they have witnessed/ experienced in the city centre, on the existing PSPO restrictions and on possible revised / new restrictions.
- 10.3 This consultation will last for 2 months with the results brought back to the Overview and Scrutiny Management Committee at its meeting on 26 April 2018, to review and to make recommendations to the Cabinet Member for Licensing and Regulation and to Council as to what restrictions ought to feature in the revised order.
- 10.4 At its meeting on 26 April, it is suggested that the Scrutiny Committee invites the following:

- Council Officers Public Protection, Street Scene and Housing Needs
- · Representative from Gwent Police,
- · Representative from the Business Improvement District,
- Stow Hill Ward Councillors
- Representative from the Wallich charity

The purpose of this would be to enable the Committee to hear views and evidence as to what is occurring in the city centre and on a revision of the PSPO. We would like to see any proposed city centre PSPO have the support of those affected by it.

11. What is Scrutiny being asked to do?

At this meeting:

- Hear from the Police/ council officers as to what has been happening in the city centre over the past two years; consider how effective is the current PSPO and whether it should be continued after November 2018, and if so, what restrictions should it contain to increase its effectiveness; hear what other city centres have done by way of PSPOs.
- 2. Consider revised/ new restrictions.
- 3. Approve a consultation strategy, see **Appendix 3**.

At its meeting on 26 April 2018:

- 4. Oversee the consultation process to ensure it is robust, and that the outcomes are taken into consideration in drafting an Order that would have public support.
- 5. Consider the results of the consultation, and hear evidence from Council officers, Gwent Police and other representatives on the proposed changed.
- 6. Make recommendations to the Cabinet Member for Licensing & Regulation and Council regarding the restrictions that could / should be included in a revised Order.

12. Approving the City Centre PSPO

The results of the consultation, including any comments from the Scrutiny Committee, will be reviewed and a draft, revised PSPO produced for consideration by the Cabinet Member and Council. Final approval will be by full Council and will last for a further 3 years, although it may be reviewed at any time.

Appendix 1

PSPO City Centre Community Safety Wardens Involvement from May 2016- October 2017

Since the Pill PSPO was introduced in July 2017, there has been a migration of street drinkers back to the City Centre Mariners Green and St Pauls Walk. This group of drinkers was in Pill by the old Kwik Save. It may be as the weather gets cooler, they may disappear again until the spring. There has been an increase in the number of beggars. Incidents of dogs off leads have all but disappeared.

The Wardens have issued: 4 PSPO FPNs for breaches where the person has refused after being asked to stop their activity; 2 issued for Begging and 2 for refusing to stop drinking alcohol. Those not paid referred to Legal for possible prosecution.

Anti-social behaviour continues to be the focus for the city centre ward policing team. Of the 325 calls in the six month period (see below for detail).

93 involved youths; 29% 22 involved begging; 7% 29 involved alcohol: 9%

Commentary Youth ASB

Many of the calls to the police commence from 1500 hours and peak around 2000 hours daily. Students returning from school and using the bus stations is a key factor in the rise in calls between these times.

Youths loitering near fast food outlets are the subjects of many complaints from members of the public and business owners who are either confronted by youths or feel intimidated by their presence when walking past them.

There is a peak on the weekend with the Night Time Economy accounting for the increase in reported ASB and the way the police now record incidents.

High Street has been and remains the highest area for recorded ASB in the city centre.

Begging Begging is an issue which is vastly under reported to the police; however it is one of the main complaints encountered by patrolling officers from members of the public, along with complaints of rough sleeping.

Begging starts around 1100 hours and continues until late afternoon with regular spots being used. These spots are generally identified as cashpoints and car park vending machines etc.

On the weekend the beggars focus changes to those persons frequenting the City centres nightspots and they can be seen loitering around the cashpoints on Westgate Sq., Bridge St and Cambrian Rd. Those persons who are begging but are known to have accommodation and who are exploiting the generosity of members of the public are being identified and dealt with by the issue of Community Protection warnings and Community Protection notices that generally carry a fine from the Magistrates' court.

The Friars Walk shopping complex also suffers from beggars who loiter around their pay and display machines in the car park. The situation has been managed by their use of security guards who move on those that choose to beg in that area.


ASB involving drink or drugs

Many of the calls to Police involve the use of drink or drugs and on a daily basis it is the same people that are identified as causing the issues. Many of those identified as street drinkers are involved with various agencies to address their drink and or drug problems. However, groups of drinkers will congregate in area of high footfall to drink their alcohol and this has an increase in ASB. Recently there has been a drive to curb their behaviour with the issue of PSPO fixed penalty notices tickets and commute protection notices issued to exclude persons from the area.

Rough Sleeping

Newport city Centre has its share of rough sleepers like any other large town or city in the UK. Calls to the Police regarding rough sleeping are generally from businesses that have to deal with the waste left behind. This waste can be both human and general rubbish, along with drug paraphernalia i.e. needles and used silver foil.


Members of the public also complain to the police about rough sleepers setting up tents on the frontage of shops, although this practice appears to have diminished over the last couple of months. Newport has its regular rough sleepers but as the Christmas period comes closer there is usually an increase in numbers on the City centre attracted by charities opening their doors and providing accommodation during the colder months.

A PSPO is an official measure that is an enforceable part of the Anti-Social Behaviour, Crime and Policing Act 2014. PSPOs can be used to protect the public from behaviour that is having, or is likely to have, a detrimental effect on the quality of life of those in the locality and is persistent and unreasonable (or likely to be).

A City Centre Public Space Protection Order

The current PSPO was setup by Newport City Council in November 2015 and will expire in November 2018. So it is now timely to review the order to see whether the current restrictions are appropriate and whether they need amending, or whether new restrictions should be added to a city centre PSPO to combat anti-social behaviour in the city centre.

All persons whilst in any public place are prohibited from ingesting, inhaling, injecting or smoking or be in possession of any substance with the intent to ingest, inhale, inject or smoke which has the capacity to stimulate or depress the central nervous system and/or it affects the person's mental functioning or emotional state.
- 2. This prohibition does not apply where:
 - a) The substance is used for valid and demonstrable medicinal purpose;
 - b) The substance is given to an animal as a medicinal remedy;
 - c) The substance is a cigarette (tobacco) or vaporiser; or
 - d) The substance is a food product regulated by food, health and safety legislation.

Persons within this area who breach this prohibition shall: surrender psychoactive substances in his/her possession to an Authorised Person.

Disposal of the alcohol or psychoactive substance may be undertaken by the Authorised Person in whatever way he or she thinks fit.

C - Prohibition on Anti-Social Behaviour within the Restricted Area (land hatched red Map B.1)

1. Persons are prohibited from intentionally or recklessly, shouting, swearing, screaming or acting in a manner to cause, or likely to cause, annoyance, harassment, alarm or distress to any person.

D - Prohibition on aggressive begging within the Restricted Area (Map A.1)

1. Persons are prohibited from aggressive begging within the borough. For example by loitering around cash machines and shop entrances for the purposes of aggressive begging. For the purposes of this prohibition, loitering means 'standing or waiting around without apparent purpose'. Aggressive begging is not limited to approaching people and/or asking for money, or placing a receptacle for donation.

Derby (proposed)

No person shall ingest, inhale, inject, smoke or otherwise use intoxicating substances in a public place, excluding alcohol, tobacco or prescription medicines. Intoxicating substances are psychoactive substances with the capacity to stimulator depress a person's central nervous system and are referred to as New Psychoactive Substances (NPS).

No person shall beg (using either active or passive methods of obtaining alms) or ask members of the public for money in a public place.

No person shall consume alcohol in a public place (excluding licensed premises) in a
