Summary There were 23 applications received for grants from the Welsh Church Acts Fund for 2017/18.

Proposal That the Cabinet Member:

- approves 17 applications, totalling £49,694 of grants, as shown in Appendix One
- agree moving to a bi-annual application process from 2018/19, as described in paras 5, to be reviewed after 2 years of operation
- reviews the application process and detailed criteria, in conjunction with the HoF, as described in paras 5

Background

1. Newport City Council receives an amount each year for distribution under the Welsh Church Acts fund to be distributed in accordance with the adopted criteria. For 2017/18 the amount available for Newport City Council to distribute is £50,539.94, inclusive of £139.94 carried over from 2016/17.

2. There is set criteria for the payment of this grant, ultimately decided by the Church authority, and this has been augmented with local criteria / interpretation guidance which Scrutiny committees have reviewed in the past. The Lead Member has been given a copy of those. The Head of Finance considers the applications initially with the Senior Finance Business Partner and the Corporate Admin Supervisor and makes recommendations for those which fall within the criteria.

3. Appendix 1 lists 23 applications for consideration, of which 17 meet the Welsh Church criteria. The total grants requested from the 17 applications amount to £82,823.99, and therefore it is not possible to pay 100% of the grants requested as it exceeds the funds available. It is therefore proposed to pay 60% of all application amounts and this will total £49,694.39 (£50,414.39 including £720 for U3A for a defibrillator previously approved), leaving a very small balance to carry forward into 2018/19. This follows the same pattern as all other previous years.

Going forward

4. Two issues have emerged following the review of applications this year:

1. Within the applications received for this financial year, were an increasing number of larger value applications for equipment for established groups or clubs, which we are recommending that the Cabinet member approves. These are received each year but are not normally significant and normally, only about 2-3 applications are received for this kind of thing but they have been growing over the last 2 years of so. These types of applications have been approved in the past and we have been consistent, this time, with our approval process to previous years. However, criteria set by the Welsh Church Fund imply that equipment should only be approved for new clubs or groups where equipment is needed for the setup of those groups.
2. A few Members have made representations on the annual process which means applicants could be waiting nearly 12 months before their applications are reviewed and any awards made. It was moved to an annual process some 4 years ago because in previous years, a twice yearly process meant that either (i) the annual funds available were split into two and applicants in each half year received different percentages of their bids, depending on the number and value of other applications received in that same half year or (ii) if a consistent percentage was applied, it inevitably led to funds not allocated and carried forward.

An annual process has meant that all successful applicants received a consistent percentage of their total bid and virtually all funds are allocated, bar a small amount for 'emergency' applications.

It is likely that the increasing number of applications for day to day running equipment and the need for quicker payment is linked to the cessation of the Members Neighbourhood Funds, about 3 years ago.

5. In order to deal with these issues, it is recommended that:

- The Head of Finance and his team confirms the interpretation of some parts of the criteria with the Welsh Church and reviews local interpretation/guidance in use at other Gwent Councils. This will be reported to the Cabinet Member and if any changes are required, recommendations could be reviewed by Scrutiny in the first instance.

The Head of Finance and his team will review the application process and the information required to support all applications and report back to the Cabinet Member. This should improve

the ability of officers and the Cabinet Member in the assessment of applications against the Church Fund criteria.

- There must be a balance between timeframes and equity to ensure consistency is applied. Therefore it is recommended to move the grant awards back to a twice a year process. The amount of funding available for each application process will need to be consistent, so the funding available will be split equally in half. The percentage funding given to each application will also have to be consistent to ensure equity and therefore we propose that all applications are funded at a maximum 50% if they meet the criteria and ensure (though it can't be guaranteed) that all applications that meet the criteria receive financial support. Funds not used will be carried forward. This will be reviewed after 2 years.

Financial Summary

The cost for this application is funded from the Welsh Church Acts Fund and has no financial implications to the council.

Risks

There are no material risks arising directly from this report.

Comments from Non-Executive Members

Councillor Al-Nuaimi

1. It is rather remarkable to see so many relatively large value application, so it is not surprising that the funds are oversubscribed to the tune of 160% relative to the funds available. At first it seems scaling down the amount requested by the applicants to a uniform 60% to be fair and equitable. However

small application seeking less than £1000 will be hit much harder than those in the £5000 plus category.

(Can I suggest that those applications (less than £1000) are paid fully or scaled down at most by 20%)

2. Historically the Welsh Church funds were used mostly for the award of relatively modest value grants. Most applications used to be in the range £500 -£1500. Applications requesting many thousands of pounds were unheard of. It was surprising to see one last year requesting and being awarded £10,000.
3. Perhaps it's timely for the criteria and size of the awards to be reconsidered. It seems reasonable that the Welsh Church funds are used to help the maximum number of recipients and such can be achieved by putting limits on the cash values of the awards made. It also seems reasonable that where scaling down has to be applied, a progressive scale favouring smaller awards is used.
4. It's pleasing to see the report proposing a twice a year allocation instead of the once per year used for the current FY. While this represents an improvement, it seems possible that with the presumption in favour of the smaller value awards, that we can actually adopt a 4 monthly cycle, where the first 2 cycles are used for applications seeking a maximum of £2000, while the 3rd cycle is reserved for those application seeking higher awards (£2000- Maximum award limit agreed). Dedicating one of the 3 cycles to larger value applications could ensure Council can utilise all the funds remaining.

Response from Cabinet Member for Communities & Resources

Thank you for your comments. My response is as follows

1. This would mean taking a two tiered approach which would be inconsistent. All bids can be treated the same if the same percentage is applied, especially if the funds are oversubscribed.
2. Noted.
3. As indicated above all bids should be treated equally and consistently.
4. Moving to more than one cycle a year is problematic as it is impossible to predict the number and the size of the applications that will be received in a particular year. This means that there is an increased risk of allocating funds in the first cycle and potentially not having enough funds to cover future cycles. This is why we moved to one session so that we knew what we had to consider and all the funds could be allocated with confidence. However, this has meant a long lead in time and therefore moving to two decision points annually was a decision that sought to strike a balance between reducing the lead times and minimising the risk of either not being able to spend the annual budget, or running out of funds.

The percentage given always depends on the level of the bids received and the available funds and that percentage will therefore vary from year to year in order to spend the funds and maximise allocations given that the bids outweigh the funds available.

Councillor Ferris:

I'd like to add my support for the grant for the Newport Pantomime Society to enable them to complete the staging. We have little in the way of social amenities in the ward and this hard working and long running group deserves support.

Councillor Jason Hughes:

As someone who has been involved with agencies that have applied for the grant in previous years I would like to express my support for this proposal. An example I am able to give where it would be of specific help is in planning for centenary events later in the year such as this year's Great War commemorative events in November. Having the opportunity to have a response earlier in the year

would have given stronger guarantees to any charities applying for a grant earlier in their schedule which would have helped. I hope this response will be of assistance to the cabinet member in coming to their decision.
