<u>Purchase of Land at Albany Street to allow Improved Vehicular Turning and Improved Safety for Pedestrians and Cyclists</u>

Options Considered/Reasons for Decision

To advise the Cabinet Member for Streetscene and Cabinet Member for Assets, Equalities and Member Development (Deputy Leader) of the proposed purchase of a small section of land at the junction of Albany Street and Aragorn Street to accommodate an improvement for vehicles turning left onto Albany Street and provide safe width for a shared use route for pedestrians and cyclists as part of the active Travel Northern Corridor works.

In 2016-17 Streetscene began works within the Shaftesbury ward to improve off and on road infrastructure for walkers and cyclists. This was part of overall Active Travel measures within the city. The aim is to increase numbers of people walking and cycling within the city, particularly those undertaking short journeys, by providing safer 'off road' links and connection between destinations. To complete the scheme the Council has identified what could be described as a 'pinch point' where user conflict already exists and without additional land the problem cannot be resolved. Therefore the Council wishes to buy the additional land identified on the attached plans, using funding for active travel provided by Welsh Government for this purpose. The Council has approached the current land owners and they have expressed a wish to sell.

The Cabinet Member for Streetscene and Cabinet Member for Assets, Equalities and Member Development (Deputy Leader) are required to consider the proposal and decide if this land should be added to the Authority's (City Services) asset portfolio.

Decision

The Cabinet Member for Streetscene and Cabinet Member for Assets, Equalities and Member Development (Deputy Leader) assess the proposal and decide upon the most appropriate option.
