Subject School Reorganisation Proposal – Expansion of Ysgol Bryn Derw

Purpose To request permission to move to formal consultation on a school reorganisation proposal “to expand the Ysgol Bryn Derw site and therefore provide additional pupil places by increasing the capacity of the school from 48 to 68 with effect from September 2019” subject to confirmation of full capital funding from the Gwent Integrated Care Fund (ICF) Capital Investment Plan.

Summary Ysgol Bryn Derw is one of two special schools within the City, accommodating pupils aged between 3 years and 19 years who have a diagnosis of Autistic Spectrum Disorder (ASD) and associated learning difficulties whose needs cannot successfully be met within either mainstream or Learning Resource Base (LRB) provision. The school, with capacity to accommodate 48 pupils, opened in September 2017. The demand for places however continues to be higher than this provision.

There is an annexe building within the grounds of the school which is currently empty. It is proposed that this building is refurbished to provide additional teaching space. This would support the development of additional facilities without any detrimental impact on provision at the school, and indeed at any other school within the City. This proposal will benefit pupils across the whole of the Newport as additional facilities will be provided to support children who have specialist needs in an appropriate and secure environment.

This report recommends moving to a period of formal consultation on this proposal in accordance with the requirements of the statutory School Organisation Code.

Background

Ysgol Bryn Derw was established in September 2017 to create a special school providing 48 full-time school places for children with ASD and associated learning difficulties across the Nursery to Year 14 groups (3-19 age range).

As per the January 2018 Pupil Level Annual School Census (PLASC) submission, there were 47 children registered as attending the school. The last remaining place was allocated for a September 2018 admission.

A re-assessment of the school capacity in the summer term of 2018 identified that an additional 8 pupils could potentially be accommodated from September 2018. All the original and additional places were filled in September 2018 and a waiting list is now in place. The school is therefore oversubscribed in the second year of opening.

The current pupil cohort indicates that there will potentially be no further movement out of the school for another four years as the oldest pupils are currently in Year 10. Given this position, and the fact that pupils can remain on roll at the school until the age of 19, there will be limited opportunities to admit further pupils during the forthcoming academic years. This could lead to those pupils currently needing a specialist ASD placement who are in our local Primary LRBs having to be placed in out of county provisions, which are costly and can be a significant distance away from a pupil's home address.

School Organisation

There is an annexe building within the grounds of the school which was previously used by the Additional Educational Needs team but is currently empty. A feasibility study has been carried out, the results of which indicate that the building could be refurbished to provide additional teaching space for 12 pupils. This would support the development of additional facilities without any detrimental impact on provision at the school, and indeed at any other school within the City.

The proposal seeks permission therefore to increase the capacity of Ysgol Bryn Derw from 48 to 68 through consolidation of the main site and refurbishment of the annexe building. Increasing capacity will reduce the potential for future out of county placements, resulting in longer term revenue savings.

Quality & Standards

The Council firmly believes that this proposal will have a positive impact on the provision and quality of educational outcomes in the special school sector. Ysgol Bryn Derw is already well-equipped to deliver a full curriculum across all year groups from Nursery to Year 14, and increasing the number of places available within the school community will not have any detrimental impact on this provision. The proposal will result in additional facilities being provided to support children who have specialist needs in an appropriate and secure environment.

Perceived benefits of the proposal include:

- Provision of additional specialist education places in an appropriate dedicated school where placement in supported mainstream environments is not deemed appropriate;
- The subsequent potential availability of places in LRBs to support pupils who require supported mainstream environments;
- Development of an existing school site;
- Reduction in current and / or future out-of-county placements and an opportunity for pupils who are currently attending out-of-county provision to re-integrate back into their local area to continue their education;
- Reduced travel time for pupils who are attending out-of-county placements;
- Provision of a wider range of spaces for pupils with ASD who find noisy and busy areas difficult.

Governance Issues

There will be no changes to school governance arrangements as a result of this proposal. The governing body will continue in its current form.

Human Resources Issues

There may be staffing implications for Ysgol Bryn Derw in terms of appointing any additional teaching and support staff necessary to support an increase in pupil numbers. This can be managed effectively through existing staff recruitment arrangements.

School Reorganisation Process & Timelines

All school reorganisation proposals are taken forward through a statutory consultation process in accordance with Welsh Government's statutory School Organisation Code. This entails the following steps and approximate timescales:

Financial Summary

The feasibility study has been carried out and identified that the required refurbishments could be carried out at a cost of approximately £300,000 (this equates to a value of £25,000 per learner based on 12 additional learners). This is significantly lower than the cost for out-of-county provision, which averages at £45,000 per learner, plus associated transport costs.

The Council has submitted a bid to the Welsh Government Integrated Care Fund (ICF) Capital Investment Plan for Gwent for full capital funding to undertake this project. The outcomes of the project clearly support two of the priorities set out by the Children & Families Strategic Partnership namely:

- *To improve outcomes for children and young people with complex needs through earlier intervention, community based support and placement closer to home.*
- *To increase the support available to children and families with complex needs to reduce the number of out of county placements and increase number of young people provided skills for living.*

The Council has yet to be advised of the outcome of this bid. However this proposal is fully dependent on its success and will not be pursued if this is turned down. There is no intent therefore to launch formal consultation until this outcome is known. The report is being taken forward in advance of the decision due to the relatively short timescale between now and September 2019, and the subsequent need to launch the proposal immediately that notification of a successful bid is received by the Council.

The proposal is considered to be cost effective in that it will support pupils living in Newport to be able to receive education suitable to their needs within the City. There will be an ongoing cost of delivery of £118,000 per annum, and this will need to be included in the Medium Term Financial Plan.

Options Available and Considered

Option 1: To continue with the current arrangements, maintaining the total capacity of the school at 48, and ensuring that the number of pupils actually on roll does not exceed this figure. This would not assist in improving existing facilities or increasing specialist provision places across the City however.

Option 2: To increase the capacity of the school from 48 to 68, thereby improving existing facilities and also increasing specialist provision places across the City. This will provide additional specialist education places for children with additional learning needs.

Option 3: To increase the capacity of the school by demolishing the Gaer annexe and building an extension to the existing school. This would require significant additional capital investment however.

Option 4: To build another special school in the city at a site to be determined. This would require the identification of a suitable piece of land and significant additional capital investment however.

Preferred Option and Why

The preferred option is Option 2. This will assist in meeting current and future demand for specialist provision and will benefit children and parents across Newport. The annexe building has sufficient space to support additional capacity and this in turn will assist in achieving an enriched and improved learning environment for pupils requiring specialist provision.

Comments of Chief Financial Officer

A bid for £300,000 has been made to the Gwent Integrated Care Fund (ICF) Capital Investment Plan; confirmation whether this has been awarded is awaited.

Creating additional capacity through the Gaer Annex at Ysgol Bryn Derw, from September 2019, will have a have an associated cost of £118,000. These estimated costs will need to be included within the Council's MTFP and will be funded through the agreed ISB.

Comments of Monitoring Officer

The proposed action is in accordance with the statutory school reorganisation procedures set out in the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code. Because Ysgol Bryn Drew is a special school for pupils with ASD and the proposals would increase the capacity of the school from 48 to 68 pupils, then this is a regulated alteration under the Code and, therefore, has to be the subject of formal statutory consultation. In accordance with the statutory procedures, a detailed consultation document must be prepared, setting out the educational reasons for the proposals, and meaningful consultation must be carried out with key stakeholders, including children and young people, who are likely to be affected by the changes. The consultation document must allow at least 42 days to respond, with at least 20 of these being school days. At the end of the formal consultation period, and in the light of any representations or objections received, the Cabinet member can then consider whether to proceed with the proposal and issue the necessary statutory notices. At this stage, the decision to proceed to formal consultation is still subject to and conditional upon ICF capital grant funding being awarded for the project

Comments of Head of People and Business Change

The proposals to expand Ysgol Bryn Derw will increase specialist provision within an appropriate, secure and local school environment. This should help deliver wellbeing benefits relating to equalities, community cohesion, improved health and economic engagement. It is noted that the proposal would be subject to statutory consultation and this should involve the school pupils.

There may be staffing implications for Ysgol Bryn Derw in terms of appointing any additional teaching and support staff necessary to support an increase in pupil numbers. This can be managed effectively through existing staff recruitment arrangements.

1. Name and description of the policy / proposal being assessed. Outline the policy's purpose.

The purpose is to seek permission to take forward a school reorganisation proposal to expand the Ysgol Bryn Derw site and therefore provide additional pupil places by increasing the capacity of the school from 48 to 68 with effect from September 2019. This proposal is subject to confirmation of full capital funding from the Gwent Integrated Care Fund (ICF) Capital Investment Plan.

This proposal supports the increasing demand for specialist education provision across the city of Newport. The demand for places in ASD specialist provision, due to the identified needs of pupils currently in Newport schools, is higher than current provision available within the city.

The proposal will benefit pupils across the whole of the Newport as additional facilities will be provided to support children who have specialist needs in an appropriate and secure environment.

The consultation period will enable Newport City Council to seek views on the proposal.

2. Outline how you have/ will involve stakeholders who will be affected by the policy/proposal

The consultation process represents an opportunity for people to learn about the proposal, ask questions and make comments. The consultation will involve two drop-in sessions with those most directly affected by the proposal, where Council officers will be on hand to explain the proposals in more details and answer any questions.

Comments and questions can be submitted using a response pro-forma. This pro-forma will be available at the drop-in sessions or can be downloaded from the Council's website. Social media facilities such as Twitter and Facebook will also be available.

Following consultation, Newport City Council's Cabinet Member for Education & Skills will consider the views expressed and then decide whether to proceed with the proposal. If the decision is taken

to proceed, a statutory notice will be published in the local press and at the school. The statutory notice period will last for 28 days following the date of publication and enables people to express their views in the form of supporting or objecting to the proposals. If no objections are received following the publication of the statutory notice, Newport City Council's Cabinet Member for Education & Skills will make the final decision as to whether to proceed. If objections are received, the final decision will be referred to the Council's Cabinet.

A Children and Young People's Everyday Summary Version consultation document is available from Newport City Council. The Council will consult with pupils at Ysgol Bryn Derw through the Headteacher and in conjunction with SNAP Cymru.

The statutory School Organisation Code outlines the key stakeholders who should be consulted with as part of this process. Following this period of formal consultation, a Consultation Report will be prepared and published on the Council website, and will be used to determine whether or not to move to publication of a statutory proposal. The FEIA will also be updated at this stage. The publication of a statutory proposal enables stakeholders to lodge legal objections against a proposal.

Ysgol Bryn Derw is already well-equipped to deliver a full curriculum across all year groups from Nursery to Year 14, and increasing the number of places available within the school community will not have any detrimental impact on this provision. 6 Will the proposal/policy have a disproportionate impact on a specific geographical area of Newport?

Ysgol Bryn Derw is already an established school accessible to pupils across the city. The proposal supports the development of additional facilities without any detrimental impact on provision at the school, and indeed at any other school within the City. This proposal will benefit pupils across the whole of the Newport as additional facilities will be provided to support children who have specialist needs in an appropriate and secure environment.

7 How does the proposal/policy relate to the parameters of debate about Fairness identified by the Newport Fairness Commission

Parameter 1 – Equal treatment while recognising difference
The proposal recognises that the children affected by the proposal require a different style of education whilst given them the same opportunities to receive a rich and nurturing education as all other children have the opportunity to in Newport.

Parameter 2 – Mutual Obligations between citizens and government
Ysgol Bryn Derw does not have a catchment area. It is primarily used to accommodate pupils residing within Newport, although if spaces exist, there is a facility to allow neighbouring LAs to purchase vacant places for their pupils. Pupils are not able to apply for a place at Ysgol Bryn Derw via the Council’s usual admission arrangements. Instead, admission is based on individual need following an assessment undertaken by the Education Inclusion Team. All pupils attending the school have a statement of Special Educational Needs. The Council determines admission taking parental preference into consideration and following consultation with the Headteacher and Governing Body as to the appropriateness of the placement.

Parameter 3 – Interdependency and reciprocity within community relations
Perceived benefits of the proposal include:

- Provision of additional specialist education places in an appropriate dedicated school where placement in supported mainstream environments is not deemed appropriate;
- Potential availability of places in Learning Resource Bases to support pupils who require supported mainstream environments;
- Development of an existing school site;
- Reduction in current and / or future out-of-county placements and an opportunity for pupils who are currently attending out-of-county provision to re-integrate back into their local area to continue their education;
- Reduced travel time for pupils who are attending out-of-county placements;
- Provision of a wider range of spaces for pupils with ASD who find noisy and busy areas difficult.

Parameter 4 – Transparency and accountability in decision making
The consultation document outlines the decision making process and is transparent and accountable in the information provided. It allows the effective democratic participation of citizens.

8 Taking this assessment as a whole, what could be done to mitigate any negative impacts of your policy and better contribute to positive impacts?

Although unlikely, if demand for provision diminishes, the school could be adapted to

accommodate pupils with other additional learning needs from within the special school sector. If demand for provision increases, the Assistant Head of Education (Inclusion) will continue to plan for future provision across the City.

9 Monitoring, evaluating and reviewing

Any questions or comments made throughout the process will be recorded and summarised in a consultation report. This report will be published on the Council's website and will be considered when the Council decides on the way forward.

Following consultation, Newport City Council's Cabinet Member for Education & Skills will consider the views expressed and then decide whether to proceed with the proposal. If the decision is taken to proceed, a statutory notice will be published in the local press and at the school.

The statutory notice period will last for 28 days following the date of publication and enables people to express their views in the form of supporting or objecting to the proposals.

If no objections are received following the publication of the statutory notice, Newport City Council's Cabinet Member for Education & Skills will make the final decision as to whether to proceed. If objections are received, the final decision will be referred to the Council's Cabinet.

10 Involvement

The consultation process represents an opportunity for people to learn about the proposal. The proposal will be available online, as a hard copy, via email and social media. The consultation will involve two drop-in sessions with those most directly affected by the proposal, where Council officers will be on hand to explain the proposals in more details and answer any questions.

Any questions or comments made throughout the process will be recorded and summarised in a consultation report. This report will be published on the Council's website and will be considered when the Council decides on the way forward.
