The Substation at Allt-yr-yn Close, Allt-yr-yn, Newport

Options Considered/Reasons for Decision

To inform the Cabinet Member for Assets & Equalities (Deputy Leader) of the action taken by Western Power Distribution (WPD), to replace a substation at Allt Yr Yn Close.

Western Power Distribution had replaced an ageing substation from land that they owned to land that was within Newport City Council's ownership and was Covenanted Open Space. Unfortunately, this was an urgent matter and completed before the appropriate Legal documentation. As a result, it was recommended the Council dispose of the land to WPD. WPD however would be required to indemnify the Council from the breach of the Open Space covenant as recommended by the Head of Law and Regulation.
