#### **Supplementary Planning Guidance to support the Adopted Local Development Plan**

##### **Options Considered/Reasons for Decision**

The Local Development Plan (LDP) was adopted by Council on 27 January 2015 and is the development plan for Newport. Draft Supplementary Planning Guidance (SPG) documents have been prepared to provide additional detail and guidance on policies in the LDP. Five SPGs have been through a six-week public consultation, four of which are updated versions of currently adopted SPG. Comments have been received and the Council has made a number of minor amendments. It is now proposed that the SPGs are formally adopted by the Council. The SPGs to adopt are:

- Waste Storage and Collection
- Planning Obligations (update to existing)
- House Extensions and Domestic Outbuildings (update to existing)
- New Dwellings (update to existing)
- Flat Conversions (update to existing)

##### **Decision**

That Cabinet Members note the comments received and any proposed amendments the Council is seeking to make. The Cabinet Members agree for the SPGs to be formally adopted.
