#### **School Reorganisation Proposal – Establishment of a new Welsh medium Primary School and the relocation of Pillgwenlly Primary School**

##### **Options Considered/Reasons for Decision**

Formal consultation concluded on the school reorganisation proposal "to establish a new two-form entry Welsh-medium primary school in Newport and as a result to relocate Pillgwenlly Primary School from its current site to the new school on the Whiteheads development".

This formal consultation was carried out between 4 July 2019 and 13 September 2019. Following conclusion of this process a consultation report, which described the consultation process and feedback received was drafted and attached at Appendix 1. The report was published on the Newport City Council website and shared with stakeholders as outlined in the statutory School Organisation Code.

This report referenced findings, which recommended that the Council move to publish a statutory proposal. During this period, legal objections can be lodged by any stakeholder, and considered before any final determination taken.

The original report to the Cabinet Member for Education and Skills, seeking permission to the proposal forward, suggested that the new Welsh-medium school be established, under a seedling arrangement, from September 2020 and that Pillgwenlly Primary would be relocated to the new school on the Whiteheads development from January 2022. Since the public consultation was launched however, the land developer confirmed that the relevant planning conditions were not discharged to enable commencement of the scheme and transfer of the school site. Until these issues were resolved the development would be delayed, therefore there was some uncertainty about over when the land transfer would take place.

In light of the above, it was recommended that the project be deferred by one full academic year meaning that:

- The seedling school would open in September 2021,
- Pillgwenlly Primary School would be relocated to the new school on the Whiteheads development at the start of the Spring term 2023, and
- The new Welsh-medium primary school would move to its permanent site in Pillgwenlly from September 2023.

### **Decision**

To move to publish a statutory notice for a period of 28 days in respect of the proposal to establish a new two-form entry Welsh-medium primary school in Newport and as a result to relocate Pillgwenlly Primary School from its current site to the school on the Whiteheads development.

### **Consultation**

Head of Law and Regulation, Head of People and Business Change and Chief Education Officer.

All members were consulted and provided with an opportunity to comment. Any comments received and response thereafter are set out in the report.
