**Subject** Community Food Organisation Support

**Purpose** To provide an overview of the financial support for Community Food Organisations to operate sustainably through the cost of living crisis and to continue support vulnerable households / individuals in Newport

**Summary** Community food organisations across Newport are experiencing financial difficulty to operate sustainably during the cost of living crisis. For many community food organisations they rely on income streams through donations from members of the public and the goodwill of organisations. With the compounding impact of decreasing income and increasing cost overheads to running buildings, community food organisations are facing unprecedented challenges and increasing demand for their services.

The Welsh Local Government Association (WLGA) has provided Newport Council £55k to support community food organisations. Using existing WLGA food poverty funding (£7k) and a Council contribution of £38k, £100k will be made available for community food organisations to support the running of their services and to meet the demand of communities across Newport

**Proposal** For Newport Council to deliver a Community Food Organisation support fund to help support ongoing revenue costs of community food organisations in Newport.

## Background

Throughout the last two years, community food organisations have made significant contributions towards supporting communities and vulnerable people with food parcels, debt advice and guidance, furniture, job advice and signposting to other public and third sector organisations. Without these organisations, many people and households would have struggled to provide food for themselves and their families, seek the necessary debt advice and support to enable long term changes to their financial, mental and physical well-being.

Across Newport there are over 35 organisations offering various food, furniture and general support to communities. In the last two years, Newport City Council has delivered several schemes using funding from the Welsh Local Government Association (WLGA) and the Council's own funding. An overview of the schemes delivered include:

1. **WLGA Food Poverty Grant (2019/20)** - £24k awarded to eight community food organisations to support their work and deliver food poverty support. £34.5k provided to Newport Live to deliver their Fit and Fed programme to support families during school holidays.
2. **WLGA Food Poverty Grant (2021/22 and ongoing)** - £125k (£54k Revenue / £71k Capital) was given to NCC. This funding was provided to Gwent Association Voluntary Organisation (GAVO) to appoint a Sustainable Food Coordinator and support organisations enabling community food organisations to access [sustainable food grant](#).
3. **NCC's Food Poverty Support (2021/22)** - £100k was allocated by the Council's Cabinet to support community food organisations. Of this commitment, £62k was awarded to 12 organisations to support their ongoing work and costs in 21/22.

### Cost of Living crisis

Over the last 12 months, the general cost of living has been increasing impacting on businesses and households in Newport and Wales. For community food organisations in Newport, these price increases have impacted most across the following areas:

- **Income streams (Donations, Shop income etc)** – Majority of the organisations in Newport are reliant on donations and income from selling goods and products). With inflationary pressures, organisations have reported seeing a decline in their income from the public and people using their services e.g. shops.
- **Energy Costs (Gas, Electric)** – The wholesale cost of energy across Europe and the UK has significantly increased over the last 12 months and are predicted to increase further. For community food organisations where they are providing food pantry and food preparation support this is affecting the ability to provide these services. There are also a several organisations which provide classes and support to households on how to prepare cost effective meals.
- **Staffing Costs** – Organisations employ staff on full and part time basis as well as those who volunteer. With the anticipated National Insurance rises and general pay, pension increases, many organisations are struggling to pay their existing staff.
- **Fuel (Petrol and Diesel)** – Fuel prices across the UK (June 2022) are now reaching over £100 to fill vehicles. Where organisations are providing additional services such as deliveries to people's homes or needing to help members of the community to access services e.g. supermarkets, doctors etc these costs are impacting on their ability to offer this support.
- **Rent increases** – Many landlords are increasing rent costs on buildings and facilities used by community food organisations. With interest rates rising, many landlords are passing on these costs to the organisations.
- **General procurement / running costs** – Many retailers and services are passing inflationary increases onto the consumer and this includes community food organisations.

These general costs are all coming at a time when organisations are seeing increases in the number of people and households needing support with food poverty, debt advice and support, and fuel costs.

## **Non Domestic Rate Relief Support**

Registered charities and other 'not for profit' organisations are entitled to mandatory relief of 80% of the rates on any non-domestic property wholly or mainly used for charitable purposes. ## **NCC / GAVO Sustainable Food Grant**

In collaboration with GAVO, community food organisations are able to access capital funding up to £3,000 to improve their storage facilities, cooking equipment, signage, furniture and travel costs.

## **Community Food Organisation Support**

In May 2022, Newport City Council received £55k from WLGA to help support community food organisations to continue to meet the needs of the people that use their services and are experiencing difficulties in operating effectively due to increases in expenditure, volunteer expenses, and the costs outlined above.

In addition to this funding, Newport Council will contribute £38k as part of a previous commitment alongside £7k from other WLGA food poverty funding that has been earmarked to support community food organisations. This contribution will provide an overall support package to £100k for organisations to access.

We will work with community food organisations and GAVO to make arrangements to distribute funding to support them with covering the costs of increasing overheads, reduction in income / donations to help maintain the delivery of their service. For any funding not claimed by September 2022 a second round of funding will be offered between October and December 2022.

Using social media and working with partners such as GAVO, NCC will promote and offer this support across the networks in Newport.

## Options Available and considered

2. To reject the proposal and for further work to consider further options to support Community Food Organisations.

## Preferred Option and Why

Option 1 is the preferred option to offer Community Food Organisations funding opportunities to support their operating costs to support communities in Newport.

## Comments of Chief Financial Officer

The financial contributions to community organisations will be made through a combination of grant and revenue funding and will be time limited. The Council's £38k contribution will be identified from within existing resources. Allocation of monies to these organisations will need to be monitored closely and will be done so as part of the Council's established ongoing budget monitoring processes.

## Comments of Monitoring Officer

There are no specific legal issues arising from the report. The proposed financial support for community food organisations is in accordance with the Council's general "well-being" powers under section 2 of the Local Government Act 2000 and is also consistent with the Council's socio-economic duty under the Equality Act and corporate well-being objectives.

## Comments of Head of People, Policy and Transformation

There are no HR implications in the delivery grant and will be undertaken within existing resources.

The well-being of Newport's communities is important during this difficult period where people are struggling to meet the cost of living. Community Food Organisations across Newport rely on donations and the goodwill of people to support those most in need. As the report has outlined, these organisations are also struggling to meet the demand of people but also continue to pay their own

overheads. The offer of this funding will help support these organisations in the short term but also provide an opportunity to meet the long-term needs of Newport's residents.

## Fairness and Equality Impact Assessment:

### • Wellbeing of Future Generation (Wales) Act

Below outlines how the Council has considered the 5 ways of working principles of the Well-being Act:

**Long Term** – The provision of the grant support will provide short term financial support to community food organisations who are struggling to meet the increase in costs and the reduction of income. The long term need is for the organisations to support the most vulnerable in their communities and to find long term solutions to their cost of living situation e.g. employment, training, housing and other support.

**Prevention** – Community food organisations help support people and families that are struggling to provide food security. Community food organisations are considered as vital community services in some of Newport's most deprived areas. The access to funding will enable these organisations support the Council's preventative work and help signpost people to other Council, charity and not for profit services in the city.

**Involvement** – The distribution of this grant funding will food organisations to support people in communities and to engage with other Council services to assist them find long term support.

**Integration** – The delivery of this grant supports the Council's strategic priorities across preventative services and community support. This work is also integrated with other organisations work in Newport such as GAVO, Newport City Homes and the community food organisations.

**Collaboration** – The delivery of this grant will be completed in collaboration with other Council departments and also involve GAVO support to promote the grant.

### • Equality Act 2010

A full Equality Impact Assessment is not required as this will be distributing grant funding to community food organisations on the basis of a grant application.

### • Socio-economic Duty

The Grant funding will provide short term support to community food organisations across Newport with the cost of delivering their services to communities. The delivery of these services contribute towards improving the socio-economic position of people and households in their communities.

### • Welsh Language (Wales) Measure 2011

The promotion and application of the funding will be made available in Welsh and English by the Council. Organisations will have the opportunity for their application to be considered in Welsh.

## Consultation

Discussions will continue to be held with GAVO, partners and senior officers to consider the best approach to distribute this funding equitably across Newport.
