- 1 Under Paragraph 20 of Schedule 8 to the Government of Wales Act 2006 the Auditor General shall, if required by a local government or other grant-receiving body, make arrangements for certifying claims and returns (referred to as grant claims hereafter).
- 2 We have completed the certification of claims and returns and conclude that the Authority had generally good arrangements in place for the production and submission of its 2016-17 grant claims. The Authority worked closely with us to ensure that an accurate and up-to-date schedule of grants was in place throughout the year.
- 3 For 2016-17 we certified 16 grant claims with a total value of £164.1 million compared to 16 grant claims with a total value of £149.8 million in 2015-16. The increase relates to:
 - 21st Century Schools the claim for 2016-17 was £11.0 million compared to £0.5 million in 2015-16. The 2016-17 claim included £10.0 million of expenditure relating to Ysgol Gyfun Gwent Is Coed & John Frost School; and
 - Non Domestic Rates Return the return for 2016-17 was £61.6 million compared to £57.2 million in 2015-16.
- 4 The Authority submitted all grant claims to us on time. This is an improvement from 2015-16, where one claim was submitted late. We can confirm that we have certified all of the claims, at a total audit cost of some £74,000 (2015-16: £71,000).
- 5 Four of the claims were qualified in 2016-17, compared to two in 2015-16. This does not indicate a significant issue with the compilation of grant claims three of the four qualifications relate to delays in the signature of underlying contracts or agreements. Amendments to the claims themselves are also minor in value (£16,347 amended out of total expenditure of over £164 million).

Summary of certification work outcomes

- 6 Detailed on the following page is a summary of the key outcomes from our certification work on the Authority's 2016-17 grant claims, showing where either audit amendments were made as a result of our work or where we had to qualify our audit certificate.
- 7 A qualification means that issues were identified concerning the Authority's compliance with a scheme's requirements that could not be resolved through adjustment. In these circumstances, it is likely that the relevant grant-paying body will require further information from the Authority to satisfy itself that the full amounts of grant claimed are appropriate.
