## 2 Context

### Background

- 2.1 The Air Quality Action Plan (AQAP) has been produced as part of Newport City Councils' statutory duties required by the [Local Air Quality Management framework](#) and spans the period 2023-28.
- 2.3 The Council's 5 Air Quality Management Areas centred around motorway junctions have all been identified for revocation in view of sustained compliance nitrogen dioxide (NO<sub>2</sub>) trends support this.
- 2.4 This AQAP focuses on the 6 AQMA's not situated at M4 junctions: Caerleon, Caerphilly Road, Cefn Road, Chepstow Road, George Street and Malpas Road.
- 2.6 Air pollution in Newport City Council's areas are undergoing transformation. Post-Covid lockdowns in early 2020, air quality impacts have not reverted to their 2019 levels and should continue their downward trends towards sustained compliance. This could be due to a number of factors including changes to working patterns, fuel prices and increasing modal change in transportation towards cleaner technologies.
- 2.7 There is a duty to Newport's citizens under the Wellbeing of Future Generations Act and under the Newport City Council Operational Climate Change Plan 2022-27 which are "inextricably linked with the improvement of air quality". Compliance is highlighted as being part of the "air quality journey", as it is important to pursue air quality improvements beyond compliance to the best achievable air quality.
- 2.8 Measures identified in this AQAP are set against the 2022 NO<sub>2</sub> levels and traffic counts. Measures have been identified by communities and the Council to have additional impacts on these levels where possible.
- 2.9 This AQAP outlines the plan to address air quality issues within Newport City Council's control. The AQAP will be subject to annual review/appraisal of progress and reporting to the Cabinet Member for Climate Change and Bio-diversity through Annual Progress Reports (ARPs) as part of the statutory Local Air Quality Management duties.
