Application

An online application made by Goschalks Solicitors on behalf of Wm Morrison Supermarkets PLC under section 17 of the Licensing Act 2003 for the grant of a Premises Licence was served on the Licensing Authority of Newport City Council on 16th December 2016. (A copy of the application can be found in Appendix 1 of this report)

In accordance with statutory provisions, copies of the application were served on each of the responsible authorities and details of the application were advertised on the premises and in the South Wales Argus, giving the responsible authorities and any other persons until midnight on 13th January 2017 to make written representations.

The Petrol Filling Station stands on the site where a large Morrison Supermarket is located and has been trading since before the Licensing Act 2003 became law on 24th November 2005. The Petrol Filling Station current hours for trading are 05:30 until 22:30 (Location and photographs can be found in Appendix 2 of the report.)

Wm Morrison Supermarkets PLC seeks the grant of a Premises Licence that would permit the Petrol Filling Station to provide the licensable activities of the Sale of Alcohol for consumption 'off the premises' and Sale of Late Night Refreshment. The application proposes that Kelly Louise Nichols is to be specified as the Designated Premises Supervisor and her signed consent is included within a copy of the application (Appendix 1).

1. Licensable Activities

The application seeks to be granted a Premises Licence for the authorisation of :

- Sale of Alcohol. Monday to Sunday inclusive between the hours of 00:00 and 24:00
- Provision of Late Night Refreshment. Monday to Sunday inclusive between the hours of 23:00 and 05:00

2. Mandatory Conditions of a Premises Licence for Off Sales

- 1. No supply of alcohol may be made under the premises licence:
 - i) at a time when there is no designated premises supervisor in respect of the premises licence; or
 - ii) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3. Where at specified times one or more individuals may be at the premises to carry out a security activity, each individual must be licensed by the Security Industry Authority.

For the purposes of this section:

- i) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies; and
- ii) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.
- 4. (1) The premises licence holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
 - (2) The designated premises supervisor in relation to the premises licence must ensure that the

supply of alcohol at the premises is carried on in accordance with the age verification policy.

- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-
- (a) a holographic mark, or .
- (b) an ultraviolet feature.
- {b New Mandatory condition for on and off sales from 28 May 2014}
- (1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- (2) In this condition:-
 - (a) "permitted price" is the price found by applying the formula $P = D + (D \times V)$, where-
 - (i) P is the permitted price,
 - (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
 - (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
 - (b) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
 - (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence-
 - (i) the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence:
 - (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
 - (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- (3) Where the permitted price would not be a whole number of pennies, the permitted price shall be taken to be the price rounded up to the nearest penny.
- (4) Where the permitted price on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax, the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

3. Promotion of the Licensing Objectives

The applicant has described in an Operating Schedule, the steps that will be taken to promote the four licensing objectives if the application is granted. These are contained in section 18 of the application form at Appendix 1 to this report.

4. Representations

Responsible Authority Representations

On 03rd January 2017 a representation (Appendix 3) was received from Steve Pontin of Newport City Council Licensing Authority in his capacity of a 'responsible authority' objecting to the application with a proposal that if conditions detailed in the representation were agreed by the applicant, the objection would be withdrawn.

This representation was forwarded to Goschalks Solicitors on 04th January 2017 who responded on 09th January 2017 seeking slight amendment to the wording of the conditions 3 and 4 proposed within the representation from Mr Pontin.

This response was communicated to Mr Pontin who accepted the re-worded conditions and formally withdrew the objections of the Licensing Authority. The amendments to the wording of these conditions are detailed in Appendix 3.

5. Policy Considerations

Relevant extracts of the Statement of Licensing Policy as regards this application include:

- IMP 1 The Council will normally grant applications for premises licences and club premises certificates subject to conditions which are consistent with the Operating Schedule and any mandatory conditions prescribed within the Act. Where relevant representations are received the Council may impose additional conditions as considered necessary in order to promote the licensing objectives which arise out of those representations.
- IMP 2 The Council will strike a fair balance between the benefits of a licensed premises to a community and the risk of disturbance to local residents. Consequently in certain areas, upon receipt of representations by any Responsible Authority or any other person, the Council may restrict the hours of operation of licensable activities.
- IMP 3 The Council will normally grant premises licences for a time period of not earlier than 10.00 a.m. and a terminal hour of no later than 11.30 p.m. for those premises licensed to sell alcohol for consumption on the premises and which are located in primarily residential areas. However, hour's beyond11.30 p.m. may be permitted:
 - a. for premises located in predominantly commercial areas, such as the City Centre and where there is a high level of accessibility to public transport services; or
 - the licensable activities would not be likely to cause adverse impact especially on local residents, and that, if there is a potential to cause adverse impact, appropriate measures will be put in place to prevent it;
 - c. there will not be any increase in the cumulative adverse impact from these or similar activities, on any neighbouring residential area and the activity will not be likely to lead to a demonstrable increase in car parking demand in surrounding residential streets or on roads.
- G2 The Council will attach conditions to licences, which are tailored to the individual style and characteristics of the premises. Such conditions will normally be drawn from the Council's pool of conditions. Where appropriate, additional conditions will be formulated based on an individual case following receipt of relevant representations.

6. Legal Considerations

The decision must be taken following consideration of the representations received with a view to promoting the licensing objectives which are:

- a. Prevention of crime and disorder
- b. Public Safety
- c. Prevention of Public Nuisance
- d. Protection of Children from Harm

In each case the Sub-Committee may make the following determination:

- a. To grant the application as applied
- b. To grant the application and modify what is requested by the application in respect of activities, times and conditions, by altering, omitting or adding to them, where relevant.
- c. Reject the whole or part of the application.

All decisions taken by the Sub-Committee must

- a. be within the legal powers of the Council and its Committees;
- b. comply with any procedural requirement imposed by law;
- c. be undertaken in accordance with the procedural requirements imposed by the Council eg. standing orders and financial regulations;
- d. be fully and properly informed;
- e. be properly motivated;
- f. be taken having regard to the Council's fiduciary duty to its taxpayers; and
- g. be reasonable and proper in all the circumstances.

e) The protection of children from harm

All staff engaged in the sale of alcohol will receive suitable training (including refresher training) in relation to the proof of age "Challenge 25" scheme to be applied on the premises. The following forms of identification are acceptable: photo driving licence, passport, proof of age standards scheme (PASS) card, Military ID and any other locally or nationally approved form of identification.

Band E (£125001 and over) the fee is £635.00*

*If the premises rateable value is in Bands D or E and the premises is primarily used for the consumption of alcohol on the premises then your are required to pay a higher fee as follows:

Band D (£87001 to £125000) the fee is £900.00





TO AN APPLICATION UNDER SECTION 17 LICENSING ACT 2003 FOR A PREMISES LICENCE IN RESPECT OF 'Morrison's Petrol Filling Station, Azalea Road, Rogerstone, Newport, NP10 9SA served upon the Licensing Authority on 16 December 2016.

Newport City Council's Licensing Authority acting in its capacity as a 'Responsible Authority' by virtue of Section 182 (4) Licensing Act 2003 (amended guidance) wish to object to the grant of a Premises Licence as detailed above on the grounds that the application does not provide clear, measurable and enforceable provisions for promotion of the four 'licensing objectives' of:

- Prevention of Crime and Disorder
- Prevention of Public Nuisance
- Public Protection
- Protection of Children from Harm

In this respect, this Authority acting in its role as a 'responsible authority' would withdraw its representation if the applicant volunteered the following conditions alongside those which were proposed within the application, to be attached to the premises licence if granted, in order to promote the 'licensing objectives'.

- 1. CCTV cameras shall be in place which record all licensed areas of the premises. CCTV shall be operational at all times when the premises are trading. All recordings shall be retained for a minimum of 28 days and shall be made available to an Authorised person on request.
- 2. The Premises Licence holder shall ensure that everyone employed within the premises receives regular training in respect of their responsibilities under the Licensing Act 2003. Such training will be documented in a training record manual and produced upon request of police or an authorised officer of any responsible authority.

- 3. The nationally used 'Challenge 25 Scheme' will be operated and any person attempting to purchase alcohol who do not appear to be over the age of 25 will be required to produce proof of age in the form of a photo-card driving licence, passport or PASS approved holographic identity card. Failure to produce such identification will result in refusal of entry or sale of alcohol. Challenge 25 Notices shall be displayed at the entrance, where alcohol is displayed within the premises and at the point of sale.
- 4. The Premises Licence Holder shall operate and maintain an up-to-date Register of Refusals of Sale of Alcohol, indicating the date, time and reason for refusal and brief description of person refused. This register shall be made available for inspection upon request of any Responsible Authority under the Licensing Act 2003. The DPS shall check the register once a week ensuring that it is complete and up to date and the DPS will sign the book each time it is checked.

Should the applicant agree to volunteer that the above conditions be included within the premises' operating schedule in place of those offered as part of the application, the Licensing Authority acting in its role as a 'responsible authority' would withdraw its representation.

Re. Morrison's Filling Station, Azalea Road, Newport – Licence Application (16/02505/LAPRE)

As a resident of Rogerstone I am writing to object to the granting of a 24-hour alcohol licence in respect of the above geographical locality. I contend that the key objections are as follows:-

- There are already sufficient outlets where drink is available 24 hours a day in the geographical locality above.
- It would cause disruption to residents via noise from potential increased traffic and people in the area; litter could be increased and subsequent potential harm to the environment.
- Re above, young people already congregate around fast food restaurants (e.g. the nearby McDonald's) and the access to alcohol could be a magnet for further anti-social behaviour.
- The access to alcohol around the clock could attract people from a wider area and bring with it associated disruption to local residents.
- Potential increase in drink-drive issues and dangerous driving.
- Concerns for the security of staff at the point of sale.
- Alcohol, being made available 24 hours a day from a petrol station, does not send out the right social message.
- The application is for a general licence, which means 'shots', single 'cans', 'miniature bottles' can be sold; studies have showed that the sale of these drinks encourages irresponsible drinking.
- If alcohol is sold via a hatch, the true consumer might not be present and this could mean that alcohol is being sold to the youngest and most vulnerable members of society.

I further understand that risk assessments carried out for similar applications include, but are not limited to, the provision of CCTV, the presence of a minimum of two registered security staff (from 10.00pm to 6.00am), the implementation of the 'Challenge 25 'policy and that there is a minimum of two staff on duty, one of whom must be the licence holder.

Notwithstanding the above, I believe that the same would be insufficient to properly manage a 24-hour licensed (alcohol) petrol filling station as it simply deals with security of the specific site, not the wider more complex issues highlighted above.

For these reasons, I am opposing the application for the granting of the 24-hour alcohol sale licence.

I am writing to register my objection to the application for a premises license by Morrison's Daily Petrol Filling Station, Azalea Road, Rogerstone, Newport NP10 9SA. I object to this application on the following grounds:

- 1. Concerns for the security of staff
- Alcohol, being made available 24 hours a day from a petrol station does not send out the right social message and could encourage drink driving.
- 3. Antisocial issues in a residential area the area where this petrol station is situated, is popular with youths who meet at the adjacent McDonalds restaurant; there is already evidence of excessive alcohol consumption and a vendor selling alcohol 24/7 could be a magnet for anti-social behaviour. There is already evidence of antisocial behaviour particularly at weekends and school holidays in various parts of Afon Village and sometimes in the vicinity of McDonalds. We already suffer with youths using their car horns after about 11pm on a regular basis around the vicinity of McDonalds and Morrison's
- 4. There are sufficient vendors in the area selling alcohol.
- There is no need for alcohol to be available 24 hours a day, 7 days a week.
- 6. The application is for a general licence, which means 'shots' single 'cans' 'miniature bottles' can be sold; studies have showed these drinks encourage irresponsible drinking.
- 7. Currently we have a real issue with the litter in the vicinity of McDonalds particularly in the woods off Afon Ebbw Road and Meadowland Drive and the banking off Meadowland Drive and Rivermead Way. Newport City Council have been approached to clean these areas up but have declined due to Health and Safety concerns for their staff. Morrison's themselves have made no effort in the last 10 years to get involved with litter picks in these areas. The last 2-3 litter picks have been carried out by the local Scout group and local residents. With the availability of alcohol 24 hours, this litter problem is going to get worse and it will be down to the local residents and community to sort it out

In view of the above, I would urge the Licensing Authority to refuse the application.
